There is probably no racist "leader" that I know more about than Matthew Hale. From 1999, until his conviction, I dogged him, interviewed him, baited him, and got to know his followers. In 2002, I met Tony Willow, the only other person I know who had the same passion to bring Hale to justice. Today, Hale resides in the maximum security prison in Florence, Colorado serving a 40 year sentence and his "church" is nothing more than a rag-tag bunch of skinheads who revel in their propensity for violence and dream of the day when they will once again be a force to reckon with. And, I am always happy when they are dealt another blow.

In 2002, [2] the TE-TA-MA Truth Foundation won a trademark lawsuit against Hale and he could no longer use the words "church" and "creator" in his ersatz organization that he called a "religion." This set the wheels in motion and caused Hale to seek the murder of Judge Joan Lefkow, the judge in the case. During that case, it was also determined that many "Creators" could be held responsible for the hefty fines that were imposed. Many of the members ran for cover as they didn't want to be responsible for paying the price of their involvement.

That is a brief summary of a very dynamic laden situation with more twists and turns than a coal mine. However, collecting the money has, as you can imagine, been a chore for the Te-Ta-Ma Church and the courts. The law firm of Kirkland & Ellis, has championed the cause of Te-Ta-Ma and tirelessly fought to win the case and collect the money.

Richard Warman, a prominent human rights attorney in Canada, has done a lot to assist in bringing those "Creator's" who reside in Canada to the attention of the court and to seek restitution as has been ordered. Alex DiCivta and Liz Lampman, in particular have been targeted as two who bear the responsibility for payment of this debt. DiCivta, sixteen when he joined with Hale, is now an adult. He ran the Creator's website and radio show. Lampman assisted with the Skinhead Creator site. Apparently, there is an upcoming hearing for the two. Today, **Citizens Against Hate** [3] received the following letter to Richard Warman from the folks at TE-TA-MA, and I have decided to print it without comment.

Only the heart, faith, produced the tenacity necessary for ten plus years, to stand up upon the law, Trademark and Divine, claim exclusive rights to use of the name. Such a bonus, to prohibit the words "Church" and "Creator" from being used together by those promulgating despicable hate/fear based philosophies.

It was a miracle that Kirkland & Ellis opened their door, offered representation in what seemed a very long shot, to prevail, at the beginning. The case record is unmistakable evidence of the effort it took on the part of some very dedicated attorneys, staying the course of this litigation, withstanding and standing up to life threatening fear/hate directed to sway their efforts. This litigation is a good example of what can be done, when the cause is just and the first steps are taken based on promptings from the Heart.

Who would believe that the anger, hate, and fear would invert and turn back upon those spewing such energy, resulting in the enemy felling itself?

In further news regarding the Hale cult, within a few weeks after the arrest of Hale in 2003, a volatile "Creator" in Austrailia, by the name of Patrick O'Sullivan, petitioned to trademark the name "**World Church of the Creator** [4]." I suppose he thought that by having the name registered to him in Austrailia the website and organization could be run from there. The Te-Ta-Ma Foundation entered an objection and asked the court not to grant the trademark and cited the fact that by using the word "Church" in the title O'Sullivan would be misleading people as to the true nature of the organization. O'Sullivan did not counter and a couple of weeks ago his petition for the trademark was denied.

At this point, we can pretty safely say that the group that held the title of the fastest growing white spremacist organization in the world has been all but laid to rest. The few who still hang on to the dream of a viable group reforming are but the minions of the man imprisoned. Without benefit of direction there appears to be no real concern that they will ever reach the numbers or the popularity of three years ago. It should not be forgotten, however, that members of this group left a trail of blood and hate across the United States and there are still a few who would do almost anything "for their race."

I found it rather amusing that during the video filmed by Craig Cobb in Kingston, New York, he kept telling people that he was a "Creator." Most people in mainstream America have no idea of what that
